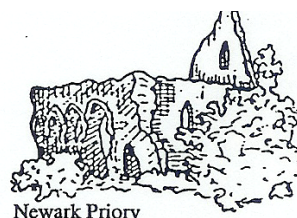

The Society was formed in 1975 and became a registered educational charity in 1987. Our museum in Ripley opened its doors in 1993. As well as exhibitions at the museum, the Society distributes a bi-monthly journal to members, which contains, as well as reminiscences, researched articles.

In addition, the Society continues to add to its range of books devoted to different aspects of the history of Send and Ripley. The Society has transcribed and indexed many documents relevant to the area and these can be accessed at the museum. We are also adding material to our website

The Society organises winter talks on a range of topics relating to local history and summer outings to places of historical interest.

Membership is by annual subscription; £14 for a single person or £18 for a couple.

This includes the bi-monthly Journal which is delivered free locally by volunteer members. Outside Send & Ripley, an additional £7.00 is payable to cover postage. There is an option to receive a digital version of the Journal via email. If you choose this option, no postage charge will apply.
